### **PAYMENT INFORMATION**

1. All tuition, costume & competition payments must be made promptly. All payments more than 10 days late are subject to a late fee.

2. There is a \$25.00 charge for any check returned by the bank.

3. No deductions or refunds will be issued for missed lessons due to personal vacations, illness, holiday closings or cancellations due to inclement weather.

4. No costume credits or refunds will be issued once costumes are ordered. Costumes will not be distributed to families with an outstanding costume balance.

5. Any student wishing to withdraw from the program must notify us in writing. Termination will begin on the date of postmark. Credits and refunds will be issued accordingly. There will be no credits or refunds issued for mini-courses.

### **ADDITIONAL INFORMATION**

1. Make-up classes are available if they are scheduled within 6 weeks of the absence, but no later than March 30th.

2. Heartbeat reserves the right to use classroom, recital & competition photos and videos of students for promotional purposes.

3. Students may be required to purchase different shoes and/or accessories for performances.

4. Please be aware that Heartbeat is only responsible for your child during his/her registered classes.
